1. Consideration of the minutes

3. Grade Appeal eForm Process – Mr. Tabor Mullen

- The first step for a student submitting a grade appeal, is to contact the faculty member/course instructor, via email regarding the grade earned in the course. The faculty member/course instructor must provide a written response outlining how they arrived at the grade the student earned in the course.
- Once the intent to appeal has been established, Mr. Mullen, Acting Chair of the Academic Review Board, will engage that student immediately to verify that the student has a legitimate grade appeal issue, or if the issue is of a different nature. Allegations of sexual harassment or discrimination will result in the complaint being referred to the Office of Compliance.,.
- It is incumbent on the student to submit all the pertinent information necessary for their appeal.

Dr. Tracey Baham stated that a Program Coordination statement was not part of any previous academic policy. However, upon SACSCOC review in 2018 it was deemed necessary to include in an academic policy a statement on program coordination. AOP 13.09 was deemed

Due to SACSCOC requirements, statements recommended for deletion by Faculty Senate during their initial review of this policy, have been added back to the policy.

Dr. Robert Green suggested to add "or related discipline" to page one, item number one. AOP 13.09 approved with the above-mentioned edit by Dr. Robert Green.
