1. Consideration of the minutes

3. Disability Resource Center Update – Mr. Chris Dallager

- The Disability Resource Center (DRC) will no longer deliver tests to the faculty member. Faculty can pick up tests at the DRC (Montgomery Hall ground floor, room 7) or faculty can request to have DRC scan and send the completed test.
- Student accommodated test requests now require three business days advance notice. This provides an additional day to ensure adequate time for communication between faculty and the DRC staff.
- Disability Resource Center will undergo an external review February 24-25, 2022. Faculty, student, or staff who would like to be part of the communication with the reviewers, please let Mr. Dallager know.
- Captioning support can now be provided by the DRC when it is required for a student accommodation. Instructors should contact the DRC to discuss material requiring captions.

➤ AOP 12.32: Refund and Course Credit for Student Members of The Military Called to Active Duty or Deployed

After a very brief discussion, the policy was approved with no edits and will now be forwarded to the Deans Council for review.

> AOP 13.11: Academic Freedom

A motion was made by Dr. Jeffrey Haupt and a second by Dr. Melanie Loehwing to accept the policy as presented and was open for discussion.

Dr. Jeffrey Haupt asked if this policy extends protection inside the classroom from other faculty members, within the department, that may prefer another stylistic approach. Dr. Ryan stated that faculty should be sensitive to the freedom of interpretations, and this may be more of a departmental topic rather than a policy related question.

After further discussion, Dr. Ryan suggested tabling this policy and forming a sub-committee from ADC to gather more information. Group members will be Dr. Melanie Loehwing, Dr. Jeffrey Haupt, Professor Michael Seymour, and Dr. Peter Ryan.

AOP 13.11 is tabled for further review by the group listed above.
