Faculty Senate President, Robert Banik stated that Faculty Senate made some changes to this AOP, and he wanted to address those changes today and provide some background information.

On page two, after the last bullet item, the following two sentences were added by Faculty Senate:

- “Voting on the day of the General Election during Presidential election years.”
- “Other absences not appearing in the above list may be excused at the discretion of the instructor.”

Multiple council members voiced concerns about students receiving the entire day off for voting purposes and were concerned about verifying if those students voted.

After a brief discussion, Dr. Kevin Rogers made a motion to delete “Voting on the day of the General Election during Presidential election years.” Dr. Rogers also made the motion to keep “Other absences not appearing in the above list may be excused at the discretion of the instructor.” Dr. Brien Henry seconded this motion, and the motion passed with two members abstaining.
